FORT BEND COUNTY MUNICIPAL UTILITY DISTRICT NO. 23

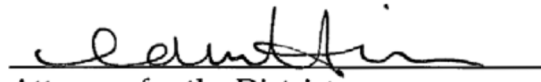
The Board of Directors of Fort Bend County Municipal Utility District No. 23 will hold a regular meeting on **Thursday, September 24, 2026, at 5:30 p.m.**, at the offices of Allen Boone Humphries Robinson LLP, Phoenix Tower, 3200 Southwest Freeway, Suite 2400, San Jacinto Room, Houston, Texas*, to discuss and, if appropriate, act upon the items listed below:

1. Public comments (maximum 3 minutes per person).**
2. **CONSENT AGENDA:** The following items are considered routine by the Board and will be enacted by one motion. No separate discussion will occur on these items unless a Board member so requests, in which event the item will be removed and placed on the Non-Consent Agenda.
 - a. Approve minutes.
 - b. Tax assessment and collection matters, including delinquent tax collections, installment agreements, and payment of tax bills.
 - c. Operation of District facilities, including billings, repairs and maintenance, customer correspondence, message language on bills, and delinquent back charges.
 - d. Phase II Small MS4 General Permit and Storm Water Management Plan, including status of compliance, necessary training and public comment.
3. **NON-CONSENT AGENDA**
 - a. Items removed from the Consent Agenda.
 - b. Review drainage facility collection and disposal matters, consider proposal from Best Trash for dumpster services, and take appropriate action.
 - c. Review Sales Tax Report and consider Amendment to Agreement for Services for Sales Tax Monitoring between the District and Revenue Management Services.
 - d. Parks and recreational facilities matters, including:
 - i. update on pending repairs and authorize additional repairs and improvements as appropriate;
 - ii. design of park facilities, plan approval, advertisement for bids, contract award, and pay estimates for park construction projects, including:
 - aa. 10-acre park tract; and
 - bb. hardscape to serve District trails, including update on Texas Parks and Wildlife Recreational Grant.
 - iii. update on new Texas Parks and Wildlife grant application.
 - e. Financial and bookkeeping matters, including payment of the bills and review of investments.

- f. Conduct annual review of Investment Policy and adopt Resolution Regarding Annual Review of Investment Policy.
- g. Review, revise, and adopt Resolution Establishing the Authorized Depository Institutions and Adopting List of Qualified Broker/Dealers with Whom the District May Engage in Investment Transactions.
- h. Conduct public hearing regarding District's tax rate, adopt Order Levying Taxes, and authorize execution of Amendment to Information Form.
- i. Engineer's report, including:
 - i. authorize design of facilities, approve plans and specifications and authorize advertisement for bids for projects in the District, including:
 - aa. Teal Run Estates Drainage Channel Rehabilitation;
 - ii. review bids and award contracts for projects in the District;
 - iii. approve pay estimates, change orders and final acceptance as appropriate, including:
 - aa. wastewater treatment plant improvements; and
 - bb. Water Supply Plant No. 1 Automatic Transfer Switch and Generator replacement;
 - iv. Capital Improvement Plan;
 - v. Chimney Rock Road;
 - vi. Westenfeldt Road;
 - vii. West Sycamore Road;
 - viii. deeds, easements, consents to encroachment, and requests for service or utility commitment requests;
 - ix. Fort Bend County drainage matters;
 - x. development in the District; and
 - xi. update on Emergency Response Plan.
- j. Additional operating matters, including:
 - i. hearing on the termination of water and sewer service to delinquent customers, authorize termination of service, and process uncollectible accounts as applicable; and
 - ii. detention and drainage maintenance.
- k. Change in operator, including:
 - i. authorize execution of contract for operating services;
 - ii. terminate existing operator-related service contracts;
 - iii. adopt Order Adopting Identity Theft Prevention;
 - iv. execution of District Registration Form;
 - v. authorize update of Emergency Preparedness Plan;
 - vi. authorize update of Critical Load Spreadsheet;
 - vii. update Payment Services Agreements; and
 - viii. review language for inclusion on utility bills.

- m. Administrative manager/building matters.
- n. District website and communication matters, including approve related proposals and correspondence.
- o. Reports from Directors and District consultants on District operations.
4. Convene in Executive Session pursuant to Section 551.071, Texas Government Code, to conduct a private consultation with attorney to discuss pending or contemplated litigation, or a settlement offer.
5. Reconvene in Open Session and authorize appropriate action regarding pending or contemplated litigation, or a settlement offer.

** A statement of no more than 3 minutes may be made of items of general relevance or related to items listed on the posted meeting agenda. There will be no yielding of time to another person. State law prohibits the Board from commenting on any statement or engagement in dialogue without an appropriate agenda item being posted in accordance with the Texas Open Meetings Act. Comments should be directed to the entire Board, not individual members. Engaging in verbal attacks or comments intended to insult, abuse, malign, or slander any individual shall be cause for termination of time privileges.
