### FORT BEND COUNTY MUNICIPAL UTILITY DISTRICT NO. 23


The Board of Directors of Fort Bend County Municipal Utility District No. 23 will hold a regular meeting on **Thursday, April 23, 2026, at 5:30 p.m.**, at the offices of Allen Boone Humphries Robinson LLP, Phoenix Tower, 3200 Southwest Freeway, Suite 2400, San Jacinto Room, Houston, Texas\*, to discuss and, if appropriate, act upon the items listed below:

1. Public comments (maximum 3 minutes per person).\*\*
2. CONSENT AGENDA: The following items are considered routine by the Board and will be enacted by one motion. No separate discussion will occur on these items unless a Board member so requests, in which event the item will be removed and placed on the Non-Consent Agenda.
  - a. Approve minutes.
  - b. Tax assessment and collection matters, including delinquent tax collections, installment agreements, and payment of tax bills.
  - c. Operation of District facilities, including billings, repairs and maintenance, customer correspondence, message language on bills, and delinquent back charges.
  - d. Review Arbitrage Rebate Report for the Series 2016 Refunding Bonds.
  - e. Garbage and recycling matters.
  - f. Phase II Small MS4 General Permit and Storm Water Management Plan, including status of compliance, necessary training and public comment.

  - iii. approve pay estimates, change orders and final acceptance as appropriate, including:
    - aa. wastewater treatment plant improvements;
  - iv. proposal for rerating the wastewater treatment plant;
  - v. Capital Improvement Plan;
  - vi. South Post Oak Boulevard extension, including sidewalks and CenterPoint easement agreement;
  - vii. Lake Olympia Parkway;
  - viii. Chimney Rock Road;
  - ix. Westenfeldt Road;
  - x. West Sycamore Road;
  - xi. deeds, easements, consents to encroachment, requests for service or utility commitment requests, including conveyance of various tracts to the District;

- iii. approve Consumer Confidence Report and authorize operator to deliver Consumer Confidence Report and file certificate of delivery with the Texas Commission on Environmental Quality; and
  - iv. detention and drainage maintenance.
  - i. Update on wastewater treatment plant oxidation ditch repair insurance reimbursement.
  - j. District security matters.
  - k. Administrative manager/building matters.
  - l. District amenities operation and maintenance matters, including:
    - i. operation and maintenance of District tennis courts; and
    - ii. request from Winfield Lakes Community Association for additional reimbursement for cost to maintain areas around Winfield Lakes detention pond and, if appropriate, approve updated Amendment No. 1 to the Maintenance Agreement.
  - m. Update on District condemnation action and take appropriate action.
  - n. Discuss 2026 Shred Event/Water Conservation Program.
  - o. Reports from Directors and District consultants on District operations.
  - p. District website and communication matters, including approve related proposals and correspondence.
4. Convene in Executive Session pursuant to Section 551.071, Texas Government Code, to conduct a private consultation with attorney to discuss pending or contemplated litigation, or a settlement offer.
  5. Reconvene in Open Session and authorize appropriate action regarding pending or contemplated litigation, or a settlement offer.

\*\* A statement of no more than 3 minutes may be made of items of general relevance or related to items listed on the posted meeting agenda. There will be no yielding of time to another person. State law prohibits the Board from commenting on any statement or engagement in dialogue without an appropriate agenda item being posted in accordance with the Texas Open Meetings Act. Comments should be directed to the entire Board, not individual members. Engaging in verbal attacks or comments intended to insult, abuse, malign, or slander any individual shall be cause for termination of time privileges.
